- 1099-DIV, -INT, -B, -G, -K, -MISC, -OID forms showing dividends, interest, broker statements, gambling income, etc.;
- No Cryptocurrency investments;
- 1095-A Health Care form, if marketplace health insurance;
- Stimulus (EIP) and/or Adv Child Tax Credit payment information;
- Any other information concerning your income and deductions;
- Photo ID and Social Security/ITIN cards;
- Bank information, if direct deposit of refund desired
